§ 1

- 1. The subject of the agreement is the provision of medical services in the field of occupational medicine for employees employed in
- 2. Approximate number of persons covered by the contract of persons.

§ 2

The scope of services referred to in § 1 includes conducting preliminary, periodic and control examinations required by the Labor Code and performed by an authorized physician.

§ 3

Under this contract, the Contractor undertakes to:

- 1. Provision of medical services for employees employed by the Ordering Party in accordance with the scope of services specified in Annex 1 to the Agreement.
- 2. Keeping records of persons referred by the Ordering Party.
- 3. Performing tests on the dates specified with the doctor.
- 4. Issuing certificates of ability to work to persons to whom the examinations relate in order to submit them to the Ordering Party.

§ 4

The Contractor will accept persons referred for examinations on the basis of a referral issued by the Ordering Party after prior registration and setting the examination date. The referral, in addition to specifying the type of preventive examination and the workplace, should contain information about harmful factors and arduous conditions at a given workplace.

The Ordering Party undertakes:

- 1. Provide information on the occurrence of factors harmful to health or burdensome conditions together with current results of tests and measurements of these factors.
- 2. Provide the opportunity to review workstations to assess working conditions.
- 3. Provide documentation of the results of the inspection of working conditions in the part relating to health protection.
- 4. Provide an interpreter to employees who do not speak Polish well enough to perform the research.

§ 6

- 1. The employee receives a medical certificate on the ability to work in 2 copies, of which 1 copy is given to the employer by the employee.
- 2. In the event of a medical certificate other than the absence of health contraindications to perform work in the position specified in the referral, 1 copy will be handed over to the employer without undue delay.

§ 7

For the implementation of the subject of the contract specified in Appendix No. 1, the Contractor will collect the amount due

according to the prices given in the annex to this agreement - Price list of examinations and services in the field of occupational medicine.

The Contractor shall notify the principal in writing of the introduction of the new price list 14 days in advance and this does not require an annex to the contract.

§ 8

- 1. Remuneration for the performance of the contract will be paid on the basis of the invoice issued by the Contractor and the attached specification according to the template constituting Appendix No. 2 to this contract.
- 2. Payments to the Contractor will be made by bank transfer within 14 days from the date of receipt of the invoice.
- 3. In the event of failure to meet the payment deadline, further hiring of employees will be suspended until payment is made.

§ 9

The contract is concluded for an indefinite period

The agreement may be terminated by either party:

- 1. With one month's prior notice in writing.
- 2. Termination by the Contractor with immediate effect if the Ordering Party is in arrears with the payment for a period longer than 1 month.
